PARTICIPATION, EXHIBITION GUIDELINES, RULES & REGULATION

OBJECTIVE OF PARTICIPATION

- The exhibition is organized to promote poultry, livestock, fisheries, agribusiness, technology, innovation, investment and trade within AKA IBOM STATE, NIGERIA, AND INTERNATIONALLY.
- The Applicant/Exhibitor shall be bound by the terms, conditions, rules and regulations set forth in this agreement.
- Any alteration must be made in writing and signed by the authorized official of IPLEL and shall have the full power to interpret, make amends, provided it does not impede the rights and privileges reserved for the Exhibitor under this contract and not increase liabilities of its sponsors, agents or employees.

FEES AND PAYMENT

- Full payment must be made before booth occupation.
- Permission to exhibit goods and services shall be granted only if payment of all fees agreed to on the reverse side is made by the exhibitor prior to the exhibition.
- Booth fees are non-refundable except if the event is cancelled by the Organizer.
- All bank charges and transfer fees are the responsibility of the Exhibitor.

EXHIBITION SPACE/BOOTHS ALLOCATION

- Booth allocation shall be based on availability and confirmed only after full payment.
- Booth size and location shall be as stated in the participant selected packaged.
- The organizer reserves the right to make reasonable changes to booth layout necessary.
- The right of an exhibitor shall not be assignable to any other firm or person.
- An exhibitor has no right to occupy any particular space except that which is allocated by the organizer, although its requirement will be taken into consideration when it comes to space allocation.

SETUP AND DISMANTLING

- Booth setup begins one day before the exhibition.
- Exhibitor is expected to comply with any building codes in line with government rules and regulations.
- Dismantling is allowed only after official closing of the exhibition.
- Early dismantling is strictly prohibited.

USE OF SPACE

- Exhibitors may only use the assigned booth space.
- Sub-letting, sharing, or transferring booths is not allowed without written approval.

TERMINATION

- The Organizer reserves the right to terminate participation without refund if the Exhibitor violates any rules, regulations or poses a safety or reputational risk.

EXHIBITION GUIDELINES

EXHIBIT DISPLAY

- Exhibitor shall not obstruct the view of adjoining exhibit or operate in such a manner objectionable to other exhibitors.
- Displays must be professional, safe, and industry appropriate.
- No obstruction of entrances, aisles, pathways and emergency exits is allowed.
- Lighting within the exhibit must be done and operated in order not to serve as a source of distraction or cause discomfort to any adjoining exhibit.
- Sound, screens, or demonstrations must not disturb others.
- Raffle draws, donations, and all promotional activities that requires unusual guests to be present at a specific location and time is not permissible. Where promotional plans are required by the exhibitor, such a plan must be approved by the organizer if it is within the guidelines so set.

PRODUCTS AND SERVICES

- Only poultry, livestock, fisheries, veterinary, feeds, equipments, agribusiness, technology, innovation, finance, and allied services are permitted.
- Sales or display of counterfeit, adulterated, expired, or illegal products is highly prohibited. Any violation will be handled according to the law.

LIVE ANIMALS

- Live animals are allowed only with prior approval.
- Health certificates and veterinary clearance from relevant regulatory agencies are mandatory.
- The organizer may restrict animal types for biosecurity reasons.



BRANDING AND PROMOTION

- Exhibitors may brand within their booth only.
- External banners, flyers, or roaming promotions require approval.
- Distribution of materials outside assigned space is prohibited.

STAFF AND BADGES

- All booth staff must be registered and wear official badges.
- The organizer reserves the right to deny access to unregistered personnel.

RULES AND REGULATIONS

HEALTH, SAFETY AND BIOSECURITY

- Exhibitors must comply with all health, safety, and biosecurity protocols.
- No hazardous materials, open flames, or unsafe equipment.
- Emergency procedures must be followed at all times.

SECURITY

- General security will be provided.
- Attendance time shall be controlled solely by the organizer who will specify the hours.
- Admission into the exhibition shall be by badge or ticket identification and shall not be transferable.
- No exhibitor will be allowed to remove his exhibit from the exhibition floor, prior to the official termination of the exhibition, and the exhibitor shall have an authorized representative present throughout the exposition and during the installation and dismantling of exhibit.
- The organizer, sponsors, agents or employees are not responsible for loss, theft, or damage by fire or injury of any nature to any person or article.

INSURANCE AND LIABILITY

- Exhibitors participate at their own risk.
- The organizer, while taking precautions against loss, will not guarantee against it and is hereby expressly released from any liabilities for injury or damage there from.
- The organizer shall not be liable for injury, loss, or damage caused by exhibitors, staff, or visitors.
- Exhibitors are encouraged to obtain adequate insurance cover for exhibit, personal effects and others including equipments for which they are responsible.

FORCE MAJEURE

- The organizer, sponsors, agents and employees shall not be liable for cancellation or delay due to events beyond reasonable control including but not limited to natural disasters, government actions, or security issues.
- The organizer shall where it become impossible or inadvisable for it to hold the exhibition at the time and place provided, reserves the right to re-schedule the exposition at another date and or at alternative site.
- The organizer (IPLEL) will not be responsible and be held harmless from the consequences of any conflicts or misinterpretations arising with the host country, its sponsors, agents or other bodies regarding any aspects of the exhibition which may affect the exhibitors.
- The said exhibitor acknowledges that IPLEL have sustained damages and losses as a result of the forgoing, as well, and shall and does hereby waive all claims for damages or compensation. The sums paid to IPLEL as fees or otherwise in connection with the exhibition shall remain the property of IPLEL.

COMPLIANCE WITH LAWS

- Exhibitors must comply with all NIGERIAN LAWS, REGULATIONS, and venue rules throughout the event.

MEDIA AND PUBLICITY

- The exhibitor by participating, have granted the organizer the right to use photographs, videos and recordings of booths and activities for promotional purposes without compensations.
- The organizer will not be responsible for errors or omissions on copy prepared and submitted for publication in the official exhibition catalogue.



VISA, PASSPORTS ASSISTANCE AND FREIGHT SHIPMENTS

- The organizer is not responsible for providing the exhibitor with assistance for obtaining passport and visa, for entrance into the country where the exposition is to be held.
- Failure in obtaining these documents from the necessary government authorities will not constitute a basis for the cancellation of this contract/application and it is clearly understood that no refunds whatsoever will be made.
- The exhibitor may however substitute another party or company who met the entry requirements and government formalities to the country to which the exposition will be held. such substitution shall be the sole responsibility of the contracting exhibitor.
- The organizer, sponsors, agents and employees are not responsible for any loss, damage or delay incurred in freight shipments into and out of the country in which the exposition will be held. Exhibitors are encouraged to adequately insure all shipments.

ABANDONMENT, CANCELLATION, CURTAILMENT AND POSTPONEMENT

- The organizer, sponsors, agents and employees are not responsible for any loss as a result of abandonment, cancellation, curtailment or postponement in part or in whole of the exhibition for causes outside its control.

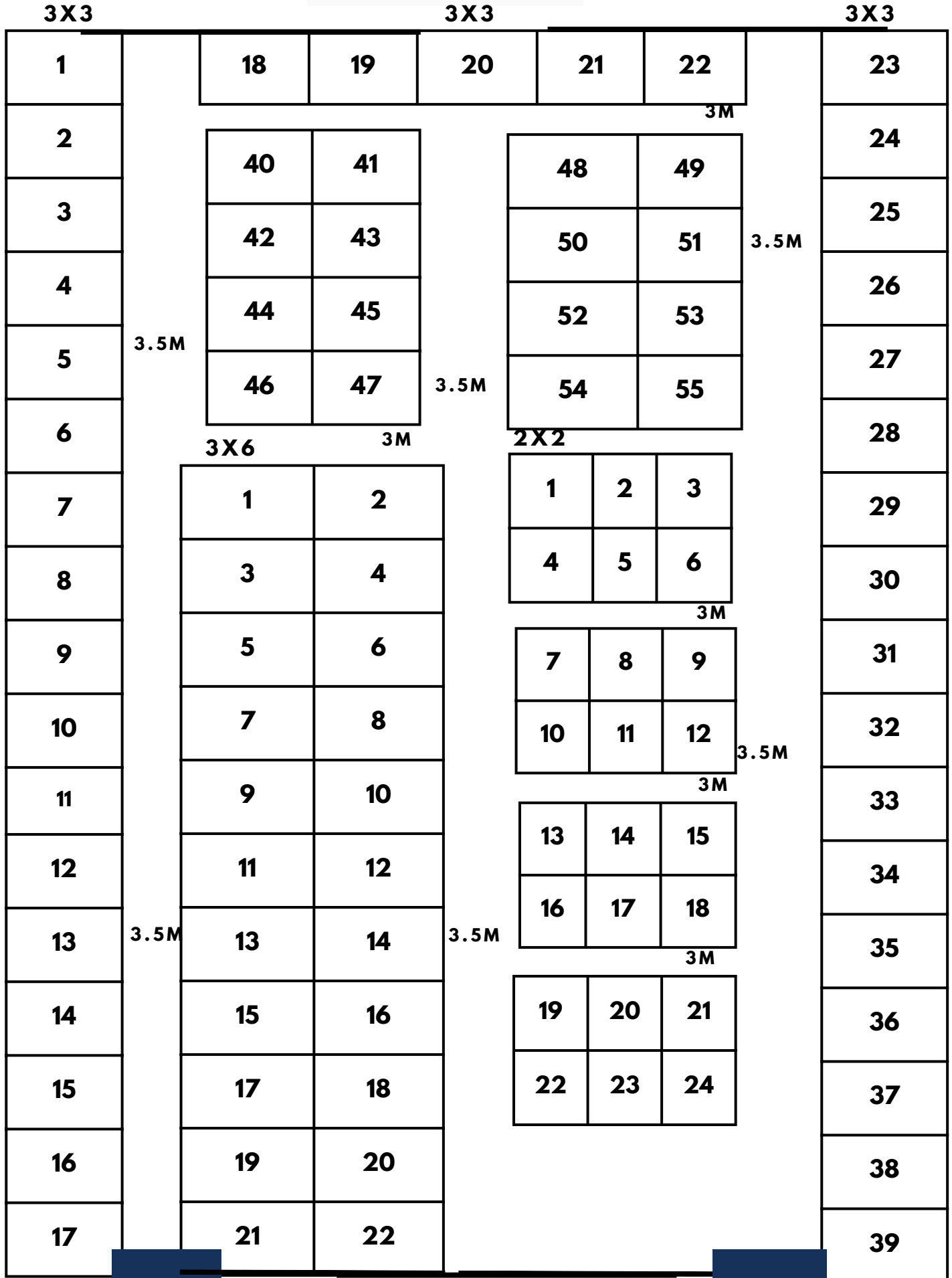
